**Atma Namaste!**

We at the Institute for Inner Studies, Inc. take this opportunity to inform all the Pranic Healers across the Republic of India of the recent developments pertaining to Pranic Healing activities in the country.

You are all well aware of the fact that certain organizations had by open declaration disassociated themselves from the Institute for Inner Studies, Inc., Manila (which is the apex body constituted with the blessings of the Grand Master having all the rights vested in it for the activities pertaining to Pranic Healing across world). Such organizations had claimed to be authorized to conduct courses relating to Pranic Healing by virtue of an illegal extension of rights to spread such teachings, made in their favor by an individual having no any authority to do so. The said organizations have been regularly conducting unauthorized courses, which are not recognized by the Institute for Inner Studies, Inc.

While in the past Institute for Inner Studies, Inc. has attempted reconciliation with these organizations, the same has failed owing to the fact that these organization/s have insisted on deviating from the hierarchy established and enforced by the Grand Master himself during his lifetime to maintain the purity of Pranic Healing teachings.

Institute for Inner Studies, Inc. together with its sister organizations and heirs of the Grand Master were forced by repeated acts of violation by these organizations/person/s of the legitimate and lawful rights of the Institute for Inner Studies, Inc. to govern the activities concerning Pranic Healing in India to approach a Court of Law in India to seek justice by filing civil suit no. 2252 of 2011 in the Honorable High Court of Delhi against the following persons/institutions:

On 14<sup>th</sup> September 2011, the Hoorable High Court of Delhi has been pleased to grant ad-interim injunction restraining Ms. Charlotte Anderson and All India Yoga Vidya Pranic Healing Foundation Trust from conducting any proposed Kriyashakti Workshop and Pranic Feng Shui Workshop in New Delhi in September 2011, and further restrain their agents, assigns, affiliates, subsidiaries, servants or any person or body claiming directly or indirectly through them from organizing and continuing to organize workshops, training programs, seminars and teachings of the Master's courses, techniques, distributing of CD's/DVD's, books, recordings of the Master's courses and as well as distributing all other items loaned to Ms. Charlotte Anderson under the licensing agreements.


We write to you to inform you of these developments and also to warn the public at large not to be misguided by the person(/s)/organization(/s) conducting Pranic Healing activities as listed above without any valid authorization to do so in view of the injunction granted by the Honorable Court. Needless to say, participation in any such classes would amount to contempt of the Court.

Further, by way of this letter, Institute for Inner Studies, Inc., Manila also wants to communicate to all the individuals/organizations that the doors of the Institute are open for every person and pranic healer who wishes to follow the Grand Master's principles for promotion and spread of Pranic Healing and is ready to adhere to the rules and guidelines formulated by the by Institute for Inner Studies, Inc., Manila under the guidance of the Grand Master with regards to the activities of Pranic Healing In India in the best interest of Pranic healing.

Needless to say, ***Forgiveness is an embedded principle of Masters' teaching*** and we at the Institute will adhere to the same in its true spirit. In the hope of a better tomorrow with all those who think for development of Pranic Healing.
